This MOU shall be effective from date it is signed by both parties.

Any financial commitment for joint activities under this MOU shall be subject to the approval by the competent Authorities of the respective organizations.

The activities under MOU shall be coordinated, monitored and recorded by an internal Coordination Committee. **Mr Anuj Sadh, Designated Partner** shall be the internal coordinator from Rand A Silk International, whereas **Dr. Nectu Malhotra, HOD and IQAC Coordinator** will be the internal coordinator from SFI. commitment of resources (financial or otherwise) required from each institution. Subsequent programme agreements must be approved in advance in writing by the authorized representatives from both parties.


